Planning

The latest plans discussed at our E.C. meeting follow:

1 Olinda Road – Change of use of ground floor from commercial office and store to self-contained flat and conversion of former butcher unit in rear yard to dwelling – no comment; **Station Retail Park, Hilderthorpe**

Road – Display of free-standing totem sign to site entrance – no comment; **62 Easton Road** – erection of two storey extensions to the front and side, single storey extension to rear, new wall and gates to driveway and alterations to roof – design not in keeping with surrounding properties; **Land East of Bempton Lane Allotments, Flamborough** – erection of 60 dwellings and associated infrastructure – support some comments of residents, need for archaeological involvement and adequate percentage of starter homes; **Cottage Farm, Main Street, Bessingby** – Listed Building consent for the installation of replacement sash windows – support; **Land South of 3 Prince Street and Land East of 29 to 31 Esplanade** – display of internally illuminated digital displays within BT street hub – is this more unnecessary street clutter?

Here are some from the September and October agendas of the Eastern Area Planning Sub-Committee: Appeals Dismissed – **Land East of 110 Easton Road** - erection of a dwelling and detached garage; **Regent Hotel Residential Home** – alterations to the existing roof to create 2 in-roof apartments. Refuse – **Land West of 19 St John Street** – outline residential development and **The Eaves, South Sea Road, Flamborough** – Certificate of Lawfulness for proposed use of property as holiday accommodation for up to 8 persons. Approved – **6 Coastguard Cottages, Lighthouse Road, Flamborough** – erection of single-storey extension to rear, porch to front, external stairs to front and raised terrace to rear, alterations to roof, windows, external finishes, parking and landscaping; **Royal Yorkshire Yacht Club, Blyth Park, Village Road, Wilsthorpe** – variation of Condition 11 of planning permission 24/00369 (erection of a new clubhouse) to allow for an amended design.
