Planning

Now, to the matrix discussed at the Executive Committee meeting on February 3rd. **Sewerby Hall & Gardens** – Listed Building consent for the pre-paint maintenance repairs to woodwork and deteriorated stonework – support the high standard and vital work to this historic community and tourist asset. It was decided not to comment on **Land North of 187 Martongate** - erection of a dwelling and associated works

following removal of existing building. There was no objection to the details required by a condition, relative to landscaping improvements, at the extension being installed for a Nitrate Removal Plant at **Water Treatment Works, Haisthorpe** or to the erection of a substation at **Gypsey Race Park East Springfield Avenue** where permission has been granted for 30 new build apartments.

The following are from the February 9th Agenda for the Eastern Area Planning Sub-Committee: Resolved that the change of use from guest house to House of Multiple Occupancy at **78 Trinity Road** be approved. Delegated – approved: **Bridlington Fire Station** – erection of a single storey extension to side; **Munton & Fison Flamborough Maltings** – erection of 3 barley storage silos with associated handling plant; **Jeans Etc, 37 King Street** – replacement of existing shop front at ground floor, replacement of existing ground floor windows and door and replacement of first floor sash window and associated window repainting works throughout first floor; **31 Fairfield Road** – change of use from a dwelling to a holiday let; **1 New Burlington Road** – change of use from dwelling to five apartments serviced accommodation and extension to rear; **Sewerby Grange** – application of render to rear and erection of a 1.9m high wall enclosing rear garden, demolition of existing wall to rear, construction of permeable gravel driveway following removal of existing block paving.
